Time: Meeting was called to order at 7:00 p.m.

Secretary's Report:

A motion was made by Rose Jurczewski to approve the May 21, 2010 minutes, and seconded by Steve Caboor. All were in favor.

Athletic Director Report:

Pete sent out the Fall 2010 home schedule followed by another one.

Fall Athletic information night is tentatively scheduled for Wednesday, August 18th, but may be changed to Wednesday, August 25th. He will let us know.

The foundation for the press box has been completed. The target date for completion is November 1. The scoreboard is completed and is awaiting installation.

Treasurer's Report:

Vice President's Report:

Kelly is going to talk to Jennifer about listing the date of the Booster meeting on the front web site home page.

Rose is going to look into ideas on signage to advertise Booster Club meetings, such as maybe a dry erase board or another type of sign. Another suggestion is to talk to Cray Allen in making banners for this.

It is suggested that maybe in the future the letters that go out to the booster members, list the Booster Club meeting dates. Also, it is suggested to add the dates to the membership book that goes out in November.

Terri will make up a list of the Booster Club meeting dates for Deb to take to sporting parent meetings.
