Athletic Director's Report:

The Lake Park XC Braus Invite is largest event held at the East Campus. We will have the concession stand open.

The Ryder Cup funds will go toward the upgrade of the football stadium. There will be a donor-recognition courtyard within the confines of the new stadium. Pete is asking the Lake Park Booster and the Band Auxiliary to consider making a minimum donation of \$5,000 towards this project so that the parent groups will be recognized on this monument. He will email a link to the plans for the new stadium for review.

#### Concession Report:

Big grill is currently at East Campus. Pete will have it moved to West Campus for Blue & White on Friday.

Terri asked Pete to check the Weber grills to see what is working. She said that we could get by with 2 small working grills and the one big grill.

#### Spirit Wear Report:

Needs volunteers for Blue & White.

Spirit Wear made \$1,155 at the Freshman BBQ.

Spirit Wear doesn't make a lot of revenue for boosters, but it is provided as a service.

#### School Store Report:

Goggles last year were \$4.75 and we sold them for \$5.00. This year our vendor is charging \$5.25. Discussed raising the price to students to \$5.50 or \$6.00.

To reduce the need for volunteers, the school store at East Campus will now be open on Monday, Tuesday and Thursday from 9:45AM – 1:10PM. The school store at West Campus will be open on Thursday and Friday from 10:00AM – 1:20PM.

#### Sponsorship Report:

Wing Stop and PJ Plumbing have been resigned for 3 year contracts. Jimmy Johns resigned a 1 year contract. Stratford Square Mall is signed to a 2 year contract for the last spot available on the Basketball scoreboard. State Farm did not resign a contract.

Currently have one available spot on the Football scoreboard and two available spots on the Baseball scoreboard.

Harris Bank chose the Conant game for their sponsor night. Athletico chose the Metea Valley game.

Discussed the Carson Coupon Book for a Fundraising idea. We need to look at options of how the boosters would sell the books. Tabled until next meeting.

Rose asked everyone to take a look at the website and get back to her with updates and ideas to improve it.

#### Fundraising Report:

Dates will be set up after we are licensed on November 1, 2012.

#### Membership Report:

Currently have 300 members, resulting in \$22,000 in revenue. Budget is over this year due to the cost of the magnets that were ordered.

#### Team Parent Meetings:

Need volunteers to go to the meetings and enlist an opener and closer for the concession stand and sign up volunteers.
