Secretary's Report: Milissa Riley made a motion to approve the February meeting minutes. Margaret Ross seconded the motion. The motion was approved.

Treasurer's Report: February checking account balance \$25,531 and the money market account balance \$76,298. A deposit of \$4400 was accidentally made to the money market account. The money has been transferred to the checking account, but the transfer is not reflected in this month's report. Sherry Schellinger made a motion to approve the February 28, 2017 Treasurer's Report. Milissa Riley seconded the motion. The motion was approved.

Athletic Director's Report: Reviewed the AD's submitted report. Milissa has emailed the Boys Gymnastic coach regarding the Krupke Invitational on Friday, March 24th to request volunteers to work the concession stand. She will also follow up with Pete.

Sherry will have a Spirit Wear table set up at the April 5th Incoming Athletic Activities Night. She plans to be at the school to set up at 6:15pm. Several board members volunteered to help sell Spirit Wear.

- a. **Vice President's Report:** Still looking for help with Boys Gymnastics, Girls Soccer and Boys Track. There a Boys Track Event one big meet and the Special Olympics that they always help with.
- b. **Concessions Report:** Discussion around options for securing the concession stand banks. The bank in the East Campus Indoor stand has been found to be short several times, but never by much. Discussed having a safe, it was determined that this would aid the closers and the treasurer but really could not be used to secure the banks. Banks are approximately \$70 each and ideally, we would have one for each of the concession stands. This discussion was tabled for a later meeting. Indoor east stand needs to have a small freezer to store hot dogs and pretzels. We will need to discuss further at our next meeting. Sam's Club is no longer carrying Sierra Mist, confirmed that 7UP is a Pepsi product that can be purchased/stocked instead.
- c. **Spirit Wear & School Store:** Sold 72 baseball hats to students for \$25 each. Hats will be available for Spirit Wear purchases moving forward. Sold 10 coaches hats for \$20 each. Payment from the coach for the coach's hats is pending.
